ANNEXURE-I

TERMS & CONDITIONS

- 1. The envelope shall be prominently marked on top with "EOI FOR CONDUCTING THE INTERNAL AUDIT OF THE SANSKRIT COLLEGE AND UNIVERSITY, KOLKATA" for the F.Y. 2023-24. The envelop should be properly sealed.
- 2. The EOI should reach this office latest by 11/12/2024 within 3:00 P.M. and the same will be opened at 3:30 P.M. on the same day in presence of the participating firms.
- 3. The bidder should be CAG empanelled audit firm.
- 4. Head Office / Regional Office must be situated in Kolkata.
- 5. Atleast 5 (five) years' audit experience in PSU/ Government (excluding Bank audit) /Educational Institution / Govt. Aided College and Universities is required.
- 6. Incomplete or conditional quotations will not be entertained.
- 7. No quotation will be accepted after the stipulated closing date and time.
- 8. The bidder may remain present himself /herself or his/her authorized representative may be allowed to be present at the time of opening of bids.
- 9. All the C.A. firms participating must submit a list of their partners etc. along with their contact numbers and a Certificate to the effect "that the firm is neither blacklisted by any Govt. Department / Institutions nor any Criminal Case is registered against the firm or its owner or partners anywhere in India" needs to be attached with this EOI. Any firm blacklisted by a Govt./Semi Govt. Deptt. shall not be considered for this EOI and the bidder concerned will be rejected straightway.
- 10. The scope of work, timelines and payment terms for the Internal Audit is attached in Annexure II.
